**Current Member Dues Deadline: March 15, 2017**

The WSWGGA is incorporated as a nonprofit organization under the laws of the State of Wyoming. A woman golfer who has proof of Wyoming residency, will attain at least the age of fifty (50) by December 31<sup>st</sup> of the year she applies for membership, has an established 18-hole handicap (GHIN or equivalent) and who has retained her amateur status may become a Member. Proof of Wyoming residency requires a valid Wyoming driver's license and/or ownership of real estate holdings in Wyoming.
